I. Amendments to RFP Deadlines

In addition to the pre-proposal conference, the Hawaii Convention Center is allowing proposers one final additional site visit. This third site visit allows the proposer the opportunity to invite its design consultants and subcontractors to review the scope of work onsite. The following guidelines will be followed:

1. Each proposer will select from one of the listed scheduled times found on page 2. Timeslots will be scheduled on a first come basis.
2. Each meeting time will be a maximum of 20 minutes long.
3. The proposer will be responsible for submitting an agenda to be approved by the HCC. HCC reserves the right to make modifications and adjustments to the agenda.
4. Questions asked during the site visit will have very limited responses.
